- Set aside the opportunity for a specific socio-economic category of businesses (e.g. 8(a) small businesses, small businesses, service disabled veteran-owned small businesses, small disadvantaged businesses, HUB Zone small businesses, and women-owned small businesses, and economically disadvantaged women-owned small businesses)
- Use the Federal Prison Industries (UNICOR) for the procurement of products
- Use Qualified Nonprofit Agencies for the Blind and other Severely Disabled for the procurement of products and services
- Utilize full and open competition where all interested vendors may consider participating in the acquisition process.
