PROPOSED AMENDMENT TO RULE 12b-25

The Commission published for comment a proposed amendment to Rule 12b-25 under the Securities Exchange Act of 1934 which would generally eliminate the extension of time procedures and would require notification if an issuer or reporting person is unable to timely file a report required by Sections 13 or 15(d) of that Act. The Commission is also proposing for comment new Rule 12b-26 under the Securities Exchange Act of 1934 which would require disclosure on the cover page of a periodic report if a required portion of that report is omitted. All comments must be submitted in triplicate to George A. Fitzsimmons, Secretary, Securities and Exchange Commission, 500 North Capitol Street, Washington, D.C. 20549 on or before November 9 and should refer to File No. S7-798. (Rel. 34-16162)

CIVIL PROCEEDINGS

TEMPORARY RESTRAINING ORDER ENTERED RE FIRST FINANCIAL GROUP OF TEXAS, INC., OTHERS

The Fort Worth Regional Office announced that on August 24 the Honorable Carl O. Bue of the U.S. District Court for the Southern District of Texas, Houston Division, entered an order temporarily restraining First Financial Group of Texas, Inc., Vining Towner Reynolds, Jr., and William H. Howton, all of Houston, Texas, from violations of the antifraud provisions of the securities laws. The entry of the order followed the filing of a complaint on the same date, in which the Commission alleged that the defendants offered and sold to banks and other institutions securities in the form of packages of government guaranteed student loans with agreement to repurchase the packages at the end of a specified term. The court set a hearing on the Commission's motion for preliminary injunction for August 31. (SEC v. First Financial Group of Texas, Inc., et al., S.D. Tex., Houston Div., CA H-79-1772). (LR-8862)

DAVID L. KIMBALL ENJOINED

The Chicago Regional Office announced that on August 24 the Honorable William E. Steckler entered a Final Judgment permanently enjoining David L. Kimball from future violations of the registration and antifraud provisions of the securities laws in connection with the sale of securities in the form of limited partnership interests of A.M. Coal Partners - 1976 A through E. Kimball consented to the injunction without admitting or denying the allegations in the Commission's complaint. (SEC v. Asset Management Corporation, et al., S.D.
