## COMMISSION ANNOUNCEMENTS

CHAIRMAN WILLIAMS SPEAKS BEFORE THE 17TH ANNUAL CORPORATE COUNSEL INSTITUTE

Chairman Williams spoke before the 17th Annual Corporate Counsel Institute in Chicago, Illinois, on October 4, 1979. The title of his address was "The Role of Inside Counsel in Corporate Accountability."

## CRIMINAL PROCEEDINGS

#### RICHARD J. ARNOLD SENTENCED

The New York Regional Office announced that on September 14 New Jersey Superior Court Judge Arthur S. Meredith sentenced Richard J. Arnold, who was previously enjoined in a Commission action on July 31, 1978, to a 5- to 7- year prison term. Arnold, who was president, treasurer, director and majority shareholder of Arnold & Co., Inc. (Registrant), a broker-dealer formerly registered with the Commission, pled guilty to 30 counts of, among other things, the embezzlement of approximately \$4.8 million from the Johns-Manville Federal Credit Union, a customer of Registrant. (State of New Jersey v. Richard J. Arnold and Arnold & Co., Inc.). (LR-8885)

#### PETER B. AHERN SENTENCED

The Chicago Regional Office announced that on September 27 Peter B. Ahern, of Novi, Michigan, was sentenced in the federal court at Detroit to a prison term of one year and to a fine of \$5,000. Ahern was remanded into custody immediately to commence his sentence. Ahern had earlier pleaded guilty to one count of fraud under the Investment Advisers Act. (U.S. v. Peter B. Ahern, USDC, E.D. Mich., Criminal No. 9-80290). (LR-8884)

#### AN-CAR OIL CO., INC. AND JOHN C. STERGE INDICTED

The Boston Regional Office announced that on September 28 a federal grand jury sitting in Boston, Massachusetts, entered a nine-count indictment charging An-Car Oil Co., Inc. and John C. Sterge, Boston, with conspiring to violate the violations of the antifraud provisions of the securities laws and the mail fraud statute. The indictment charged that An-Car and Sterge, president and sole stockholder of An-Car, offered and sold limited partnerships and fractional, undivided working interests in approximately 130 oil and gas wells located in Ohio and Tennessee to approximately 800 investors. The indictment charged that the offer and sale of these securities was effected through the use of fraudulent omissions and misrepresentations of material facts and that a substantial amount of the funds raised from investors was diverted to the personal use and benefit of Sterge. (U.S. v. An-Car Oil Company, Inc. and John C. Sterge, D. MA). (LR-8883)

### HOLDING COMPANY ACT RELEASES

#### GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until October 29 to request a hearing on a post-effective amendment filed by General Public Utilities Corporation (GPU), a registered holding company, and Jersey Central Power & Light Company, Metropolitan Edison Company, and Pennsylvania Electric Company, all subsidiaries of GPU, regarding increasing their short-term borrowing limit. (Rel. 35-21239 - Oct. 4)

An order has been issued extending through October 4, authorization previously given Jersey Central Power & Light Company, subsidiary of General Public Utilities Corporation, to conduct a program for financing the installation of insulation, attic ventilation fans and automatic day/night thermostats by its residential heating customers. Similar authorization previously given two other General Public Utilities subsidiaries, Metropolitan Edison Company and Pennsylvania Electric Company, has, at their request, not been extended. ## MISCELLANEOUS

REGULATION A EXEMPTION OF OVUTIME, INC. SUSPENDED

The SEC has ordered that the June 19, 1979 temporary suspension of the Regulation A exemption of Ovutime, Inc. from the registration requirements of the Securities Act of 1933 be made permanent. Ovutime is currently located in Newton, Massachusetts. (Rel. 33-6133)
