# U.S. SECURITIES AND EXCHANGE COMMISSION

## CIVIL PROCEEDINGS

GURN FREEMAN, SR., OTHERS ENJOINED

The Chicago Regional Office announced that on October 25 the Honorable Hubert Will, U.S. District Judge for the Northern District of Illinois, entered Final Judgments and Orders of Permanent Injunction enjoining Jack Ward Freeman, Sr., Gurn H. Freeman, Sr., Lawrence Palenshus, Thomas Randy Browne, Businessways, Inc., an Illinois corporation, Businessways, Inc., a Texas corporation, Businessways, Inc., a Missouri corporation, Businessways, Inc., a Kansas corporation, Allied Business Consultants, Inc., and Century Consultants, Inc., from future violations of the registration and antifraud provisions of the securities laws. Each of the individual and corporate defendants consented to the entry of the Final Judgments without admitting or denying the allegations set forth in the Commission's complaint. (SEC v. #### CRIMINAL PROCEEDINGS

RICHARD H. SNOOKS SENTENCED

The Chicago Regional Office announced that on October 26 Richard H. Snooks of St. Joseph, Missouri, was sentenced to 5 years imprisonment arising out of his plea of guilty to three counts of an indictment which had been returned on August 20. The indictment had alleged that Snooks engaged in a scheme to defraud investors of Citizens Loan and Savings Company of St. Joseph, Missouri, now bankrupt, by diverting substantial amounts of investors' money from the firm to his personal use and benefit.
