NOTICE OF PROPOSED AMENDMENT TO RULE 17a-1

The Commission announced that it has proposed to amend Rule 17a-1 under the Securities Exchange Act of 1934 to conform the text of that rule to Section 17(a) of the Act as amended by the Securities Act Amendments of 1975. Rule 17a-1 implements the Commission's recordkeeping and record production authority pursuant to Section 17(a) for national securities exchanges and national securities associations. Persons wishing to submit written views should file three copies thereof with George A. Fitzsimmons, Secretary, Securities and Exchange Commission, Room 892, 500 North Capitol Street, Washington, D.C. 20594 on or before December 3 and should refer to File No. S7-807. # **COMMISSION ANNOUNCEMENTS**

NOTICE OF ACCEPTANCE OF COMMENTS CONCERNING THE NASD'S PAPILSKY PROPOSAL

The Commission announced that it would accept written comments submitted by December 15, 1979, concerning a proposed rule change of the National Association of Securities Dealers, Inc. to amend its Rules of Fair Practice with respect to fixed price offerings of securities (generally referred to as the "Papilsky" proposal). In May, 1979, the Commission invited comment on a number of issues raised by the proposed rule change [Rel. 34-15807]. In addition, the Commission has been holding public hearings on this subject which are scheduled to conclude November 20, 1979. All comments should be sent with 30 copies to George A. # **ADMINISTRATIVE PROCEEDINGS**

NASD ACTION AGAINST DMR SECURITIES, INC. AND DAVID M. REINER AFFIRMED

The Commission has affirmed sanctions imposed by the NASD on DMR Securities, Inc., a Tuscon, Arizona brokerage firm, and David M. Reiner, its president. The NASD censured the firm and Reiner, and fined them \$2,000, jointly and severally. The Commission found, as had the NASD, that the firm and Reiner charged customers unfair markups in the sale of various utility bonds. The Commission stated that it was unable to find that the "relatively lenient sanctions imposed by the NASD" were excessive. (Rel. 34-16322)

I. MILLER ADVISORY SERVICES, INC., OTHERS SANCTIONED

The Commission announced that it had instituted public administrative proceedings under the Investment Advisers Act of 1940 against I. Miller Advisory Services, Inc. (Miller, Inc.), a registered investment adviser, Irwin Miller and Lewis Harris Weinstein, its president and vice president, all of New York, New York. Simultaneously, the Commission accepted a joint offer of settlement in which the respondents, without admitting or denying the allegations, consented to the entry of findings and an order revoking Miller, Inc.'s registration as an investment adviser and barring both Miller and Weinstein from association with any investment adviser. The sanctions imposed were based upon findings that, during the period from approximately February 1977 to October 1977, Miller and Weinstein wilfully caused, aided and abetted Miller, Inc.'s wilfull violations of Section 206(1) and (2) of the Advisers Act in that they failed to disclose certain facts and made false disclosures concerning (a) the minimum dollar amount needed to become a client of Miller, Inc.; (b) the number of Miller, Inc.'s advisory clients; (c) the use of proceeds of clients' loans to Miller and Weinstein; (d) Miller's and Weinstein's prior experience and results in handling clients' funds; and (e) Miller's and Weinstein's representations of future investment profits. NOTICE OF PROPOSED RULE CHANGES

The following have filed proposed rule changes pursuant to Rule 19b-4: The National Association of Securities Dealers, Inc. (SR-NASD-79-9) to discontinue giving issuers of exchange-listed securities a credit towards the fees charged for having the securities quoted in the NASDAQ System. (Rel. 34-16336); and The Options Clearing Corporation (SR-OCC-79-7) amending the timeframes during which members may submit instructions to OCC dealing with the segregation of long positions. (Rel. 34-16337)

Publication of the above proposals are expected to be made in the <u>Federal Register</u> during the week of November 12.

NOTICE OF EFFECTIVENESS OF PROPOSED RULE CHANGE

A fee change filed by the Stock Clearing Corporation of Philadelphia (SR-SCCP-79-4), pursuant to Rule 19b-4, has become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934. SCCP has raised the fee for its member-to-member envelope service from \$2.00 per envelope to \$5.00 per envelope. APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved, on an accelerated basis, a proposed rule change filed by the American Stock Exchange, Inc. (SR-Amex-79-17) to prohibit Registered Equity Market Makers from initiating off floor orders in reliance upon the market maker exemption contained in Section 11(a)(1) of the Securities Exchange Act of 1934; comments within 21 days.
