Self-Regulatory Organizations; Bats BZX Exchange, Inc.; Notice of Withdrawal of a Proposed Rule Change to Extend the Implementation Date For Certain Changes to Exchange Rules 14.11 and 14.12

On July 31, 2017, Bats BZX Exchange, Inc. ("Exchange") filed with the Securities and Exchange Commission ("Commission"), pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934¹ and Rule 19b-4 thereunder,² a proposed rule change to extend the implementation date for certain changes to Exchange Rules 14.11 and 14.12 relating to continued listing standards for exchange-traded products. The proposed rule change was published for comment in the <u>Federal Register</u> on August 18, 2017.³ The Commission received one comment letter on the proposed rule change.⁴ On September 22, 2017, the Exchange withdrew the proposed rule
