<u>IM-5050-11</u>

(a) With respect to listing Short Term Option Series in equity options, excluding Exchange-Traded Fund Shares and ETNs, which have an expiration date more than twenty-one days from the listing date, the strike interval for each option class will be based on the table below. The below table indicates the applicable strike intervals and supersedes IM-5050-6(b)(4) above, which permits additional series to be opened for trading on the Exchange when the Exchange deems it necessary to maintain an orderly market, to meet customer demand or when the market price of the underlying security moves substantially from the exercise price or prices of the series already opened.

(b) The Share Price would be the closing price on the primary market on the last day of the calendar quarter.

- (c) <u>The Average Daily Volume would be the total number of options</u> <u>contracts traded in a given security for the applicable calendar quarter</u> <u>divided by the number of trading days in the applicable calendar quarter.</u>
- (d) Beginning on the second trading day in the first month of each calendar quarter, the Average Daily Volume shall be calculated by utilizing data from the prior calendar quarter based on Customer-cleared volume at The Options Clearing Corporation. For options listed on the first trading day of a given calendar quarter, the Average Daily Volume shall be calculated using the quarter prior to the last trading calendar quarter.
- (e) Short Term Options Series that are newly eligible for listing pursuant to Rule 5020 will not be subject to this IM-5050-11 until after the end of the first full calendar quarter following the date the option class was first listed for trading on any options market.
- (f) In the event of a corporate action, the Share Price of the surviving company would be utilized.
- (g) Notwithstanding the limitations imposed by this IM-5050-11, this IM-5050-11 does not amend the range of strikes for Short Term Option Series that may be listed pursuant to IM-5050-6(b)(5) above.
