Floor Broker User fees are payable only for Cobe Options Floor Brokers accessing the Cobe Options Top data feed via Approved Third-Party Devices for managing and executing orders on the Cobe Options trading floor. Third-party vendors who distribute Cobe Options Top to Floor Broker Users via Approved Third-Party Devices must report to the Exchange the number of Approved Third-Party Devices that receive Cobe Options Top data from such third party vendor during a calendar month within 15 days after such month in the manner and format specified by the Exchange from time to time to determine applicable fees.
