New External Distributors of EDGX Options Top will not be charged an External Distribution Fee for their first three (3) months. Thereafter, each External Distributor will be eligible to receive a credit against its monthly Distributor Fee for the EDGX Options Top equal to the amount of its monthly User Fees or Enterprise Fees up to a maximum of the External Distributor Fee for the EDGX Options Top.

** As an alternative to Professional and Non-Professional User fees, a Distributor may purchase a monthly Enterprise license to receive the EDGX Options Top for distribution to a[n unlimited] defined number of Professional and Non-Professional Users. A Distributor must pay a separate Enterprise Fee for each entity for which it controls the display of the EDGX Options Top if it

wishes for such entity's Users to be covered by the Enterprise Fee. Tiers 1 and 2 will be subject to monthly reporting requirements and Tier 3 will be required to report every 6-months. The Enterprise Fee is in addition to the Distributor Fee and is non-progressive. Distributors may purchase an Enterprise license on a monthly or annual basis. Annual Enterprise licenses will receive a 5% discount.
